विषय: Comments/compliance on the visitors report of College of Veterinary and Animal Sciences, Meerut under Sardar Vallabh Bhai Patel University of Agriculture & Technology, Meerut- regarding.

महोदय,

Please refer to your Letter No.SVP/2025/R/12398 dated 17.2.2025 and letter dated 11/4/2025 of the Vice-Chancellor, Sardar Vallabh Bhai Patel University of Agriculture & Technology, Meerut on the subject cited above.

In this context, it is to inform that the said letters were considered by the Executive Committee of the Council in its meeting held on 25.4.2025. The Executive Committee observed that the progress made by the University towards fulfillment of minimum requirements in terms of teaching staff is satisfactory. However, the Executive Committee did not consider the guest faculty as teacher as there is no such provision under VCI Regulations, 2016.

However, Committee decided to advise the University that the University shall make their efforts towards fulfilment of the required number of teachers at the college for which they shall issue advertisements continuously till all the posts as required under MSVE Regulations, 2016 are filled. Further, University shall also supply the copy of such advertisements to the office of Council for information and record. If the required number of teachers are not available even after repeated advertisement, the University shall fill such posts on contractual basis as per prevailing guidelines of the University.

Further, Committee decided that the VCI shall allot 15% seats under All India quota for admission to B.V.Sc. & A.H. course under MSVE Regulations, 2016 to the College of Veterinary and Animal Sciences, Meerut from the academic session 2025-26 and onwards.

The Council in its meeting held on 29.4.2025 approved the aforesaid decision of the Executive Committee.
