

## **Training conducted to the SC farmers under “SC-Sub Plan” funded by ICAR, New Delhi**

Under “SC-Sub Plan” funded by ICAR, New Delhi, a total of six trainings were organized in various colleges to the schedule cast farmers during March 2020.

### **1. Seed Production Techniques (19-23 March 2020):**

This training programme was organized Prof. Pooran Chand, department of Genetics and Plant Breeding from 19 – 23 March 2020. A total of 40 farmers participated under this 5 days training programme. More than 10 lectures on various topics were delivered along with field visit of seed production. A kit of twenty kg of basmati rice was distribution to the farmers.

### **2. Organic Vegetable Production (17–19 March 2020 and 24 –26 March 2020):**

Training on “Organic Vegetable Production” was organized Dr. Satya Prakash, Proessor, College of Horticulture and concerned Head of Krishi Vigyan Kendra, Gautam Budh Nagar and Krishi Vigyan Kendra, Badaun respectively. Under this programme, 80 farmers participated.

### **3. Production of Clean Milk and Value Added Products (02 – 07 March 2020):**

This training programme was organized by Dr. V.P. Singh, College of Veterinary form 02 – 07 March 2020. Under this 6 days training programme, 40 farmers participated. A kits of value added products were also distributed to the participants.

### **4. Training on Fish Culture (29.02.20 to 03.03.20):**

A three day Training Programme on Fish Culture was organized by Dr. Archana Arya, Assoc. Professor, Department of Basic Science from 29.02.20 to 02.03.20. A total of 26 trainees, from 05 districts of Western Uttar Pradesh, attended the programme.

The programme was designed to impart technical knowledge on various aspects of scientific fish farming starting from construction to pond, pond management practices, fish nutrition, seed production, types of fishes grown and other species that can be cultured in the area including *Pangassius* and Giant fresh water prawn,

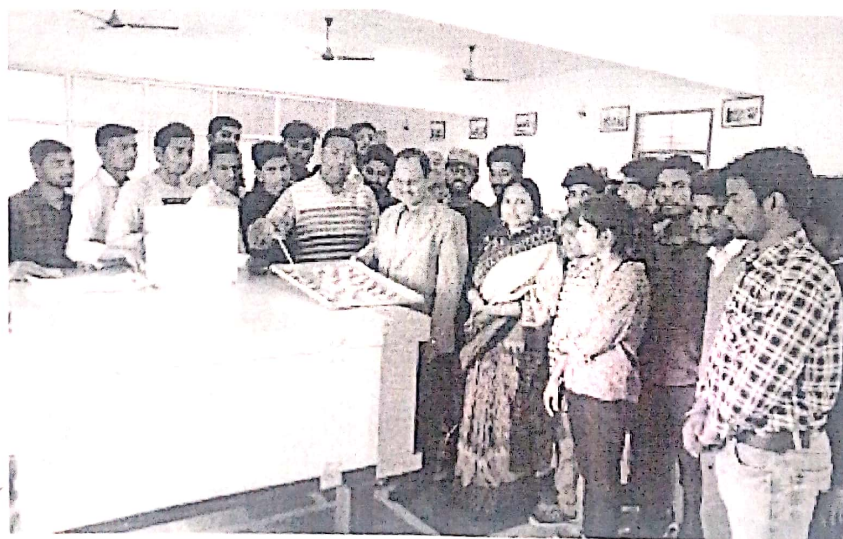
through lectures, hands on and field visit. The resource persons included fisheries experts from the university, ICAR institutes and State Agriculture department.
