Phytosanitary certification is one of the export facilitation activities for safe trade of agricultural commodities based on the WTO-SPS agreement. The certification must comply with the international norms as set in various international standards for phytosanitary measures (ISPMs) developed under International Plant Protection Convention (IPPC). It has been observed in the past that export of agricultural commodities and processed foods face rejection/ban by importing countries on account of non-compliance of sanitary and phytosanitary (SPS) standards. In view of the above, the University has established Centre of Excellence for Sanitary and Phytosanitary (SPS) with the financial assistance of Government of Uttar Pradesh & Government of India under Rastriya Krishi Vikas Yojna (RKVY) in the Department of Plant Pathology. In the SPS centre state of the art laboratories have been developed for the examination of weeds seeds, insect-pests, plant pathogens (fungi, bacteria, viruses and nematodes etc.) infestation/infection in the consignment. The main objective of the SPS centre is to facilitate/promote export of agricultural produce through export inspection and phytosanitary certification and look after SPS issues of Uttar Pradesh.
